Transfer Details

**Transfer Amount
(in whole measurements)**

TAC ACE

Complete this column only if you are transferring TAC ACE (Total Allowable Catch ACE).

TAC ACE is additional ACE which may be allocated to quota owners during the fishing year as a result of an in-season TAC increase for a stock under section 68 of the Fisheries Act 1996. Such an increase is only possible for stocks listed in the 2nd or 3rd Schedules of the Fisheries Act 1996. Quota owners will be notified if TAC is allocated to them during a fishing year.

If you are transferring any TAC ACE it must be identified separately when transferred. Please enter a new line for the TAC ACE and tick the TAC ACE column.

eg. If you want to transfer 3000kg of ACE in total, of which 500kg is TAC ACE, you must complete two lines: one line for 2500kg and one line for 500kg, with "TAC ACE" ticked.

- This application must be accompanied by the prescribed fee.

- ACE may only be transferred for the following periods:
 - The current fishing year for a stock.
 - The next fishing year for a stock (FishServe will hold this transfer until the first day of that fishing year and register the transfer at the start of that first day.)
 - The previous fishing year for a stock - but only if the transfer application is received and registered by FishServe by the 15th day after the end of that fishing year.

Collection of Personal Information

In regard to any information being collected on this form that is personal information, notification is hereby provided, in accordance with Principle 3 of the Privacy Act 1993 of the following matters:

- This information is being collected for purposes relating to the management of fisheries resources in accordance with the Fisheries Act 1996 and regulations made pursuant to the Act.
