

Application to register an Aquaculture Agreement



Section 186ZH of the Fisheries Act 1996 provides for the lodgement of an Aquaculture Agreement if the Director-General of the Ministry of Agriculture and Forestry has made a reservation in relation to commercial fishing, or has deferred making a decision on a marine farming or spat catching permit application under the Aquaculture Reform (Repeals and Transitional Provisions) Act 2004, and consents are sought from quota owners for the stock the reservation relates to. Quota holdings of consenting quota owners will be taken as at 5pm on the date on which the Director-General gives notice of the reservation or deferred decision.
